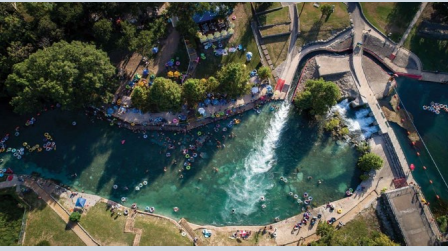

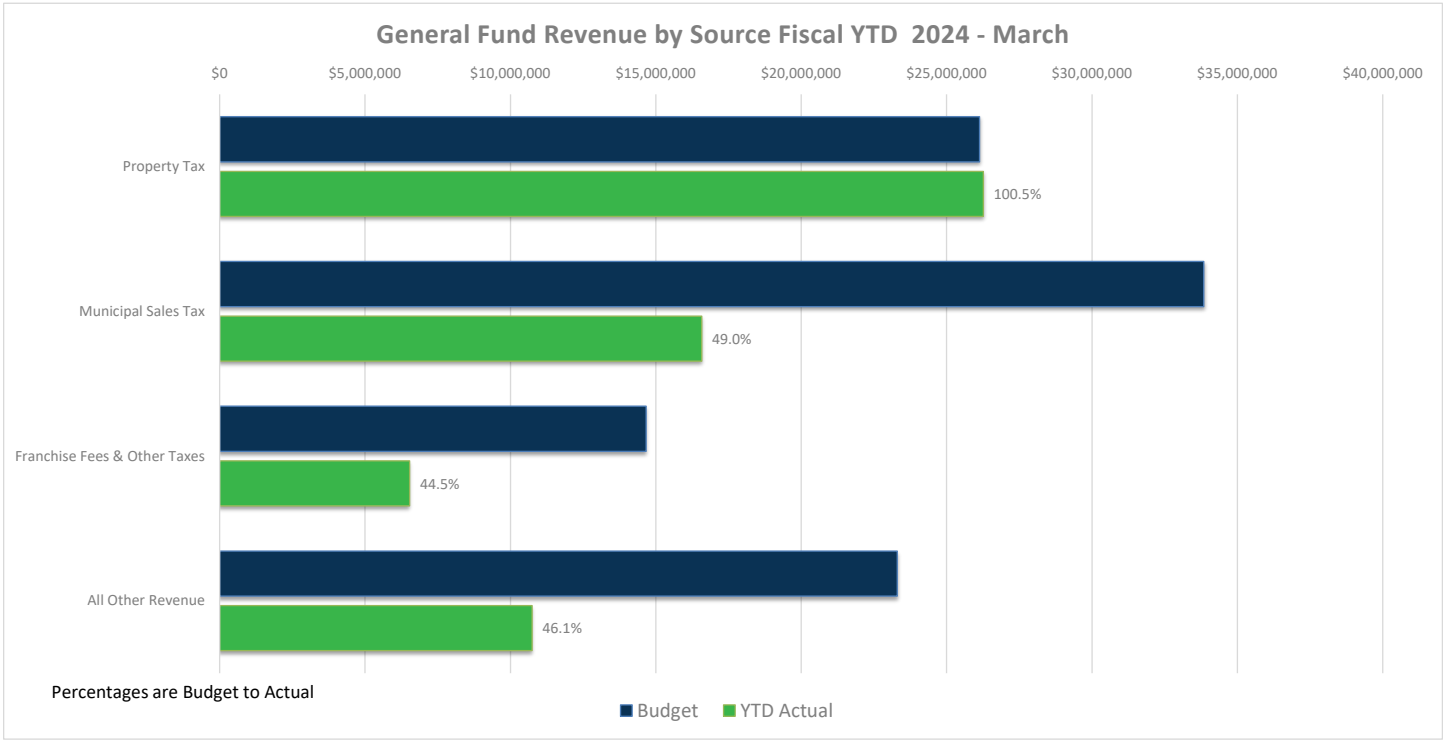
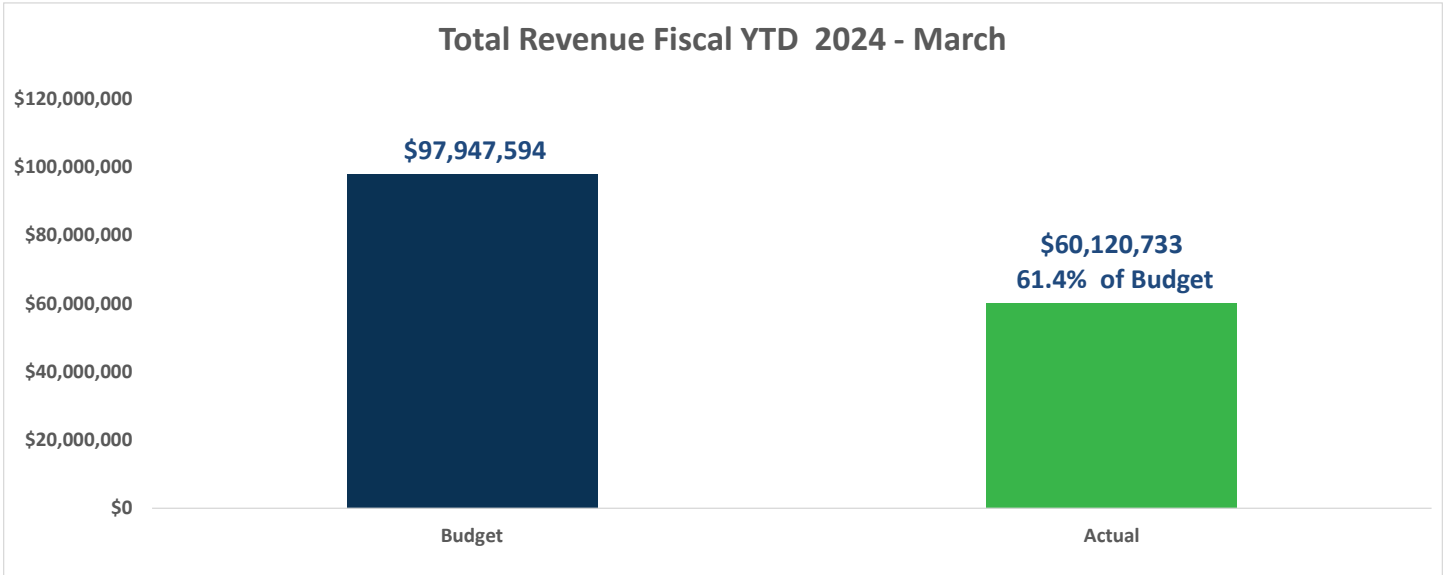
Overview

The monthly financial report is directed at providing a snapshot of the General Fund revenues and expenditures, as well as other important financial information, through the month of **March**, with 50.0% of the fiscal year complete. At the end of March, 45.6% of total payroll for the fiscal year has elapsed and is reflected in the Employee Expenses category of each fund. This report also includes a Vacant Positions Summary as of 4/30/2024, an Economic Data Report, and a report reflecting Roadway Impact Fees and Park Development Fee balances by district.

In the financial graphs, the General Fund revenues are consolidated into major revenue sources such as Property, Sales, and Other Taxes including Franchise Fees. All other General Fund revenue is consolidated for reporting purposes. General Fund expenditures are shown by department and by category.

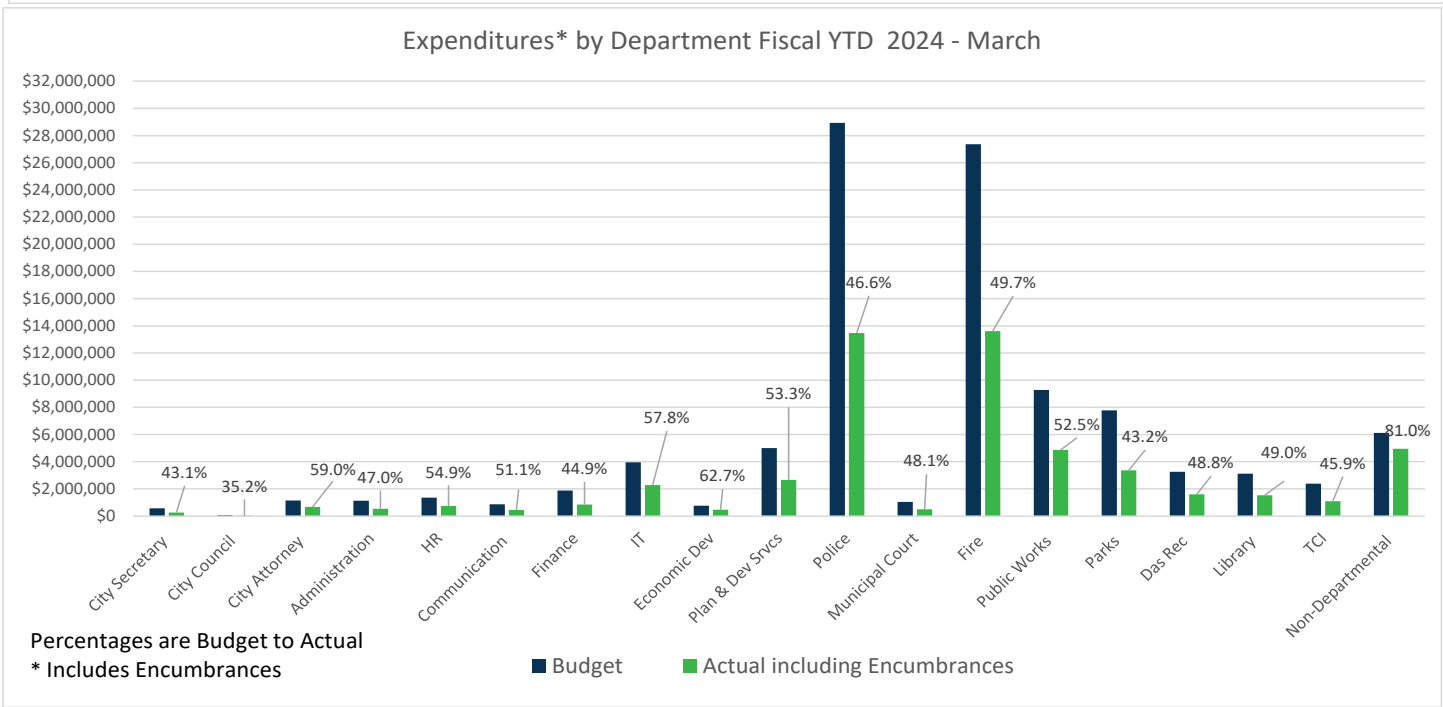
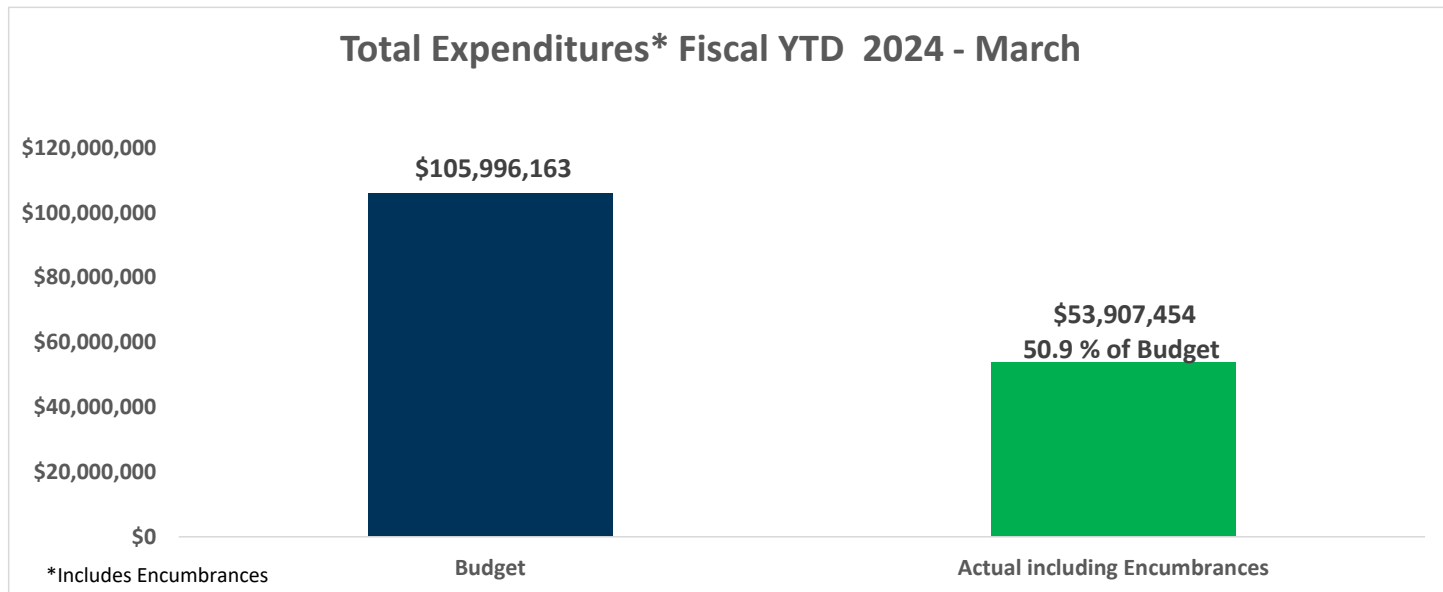

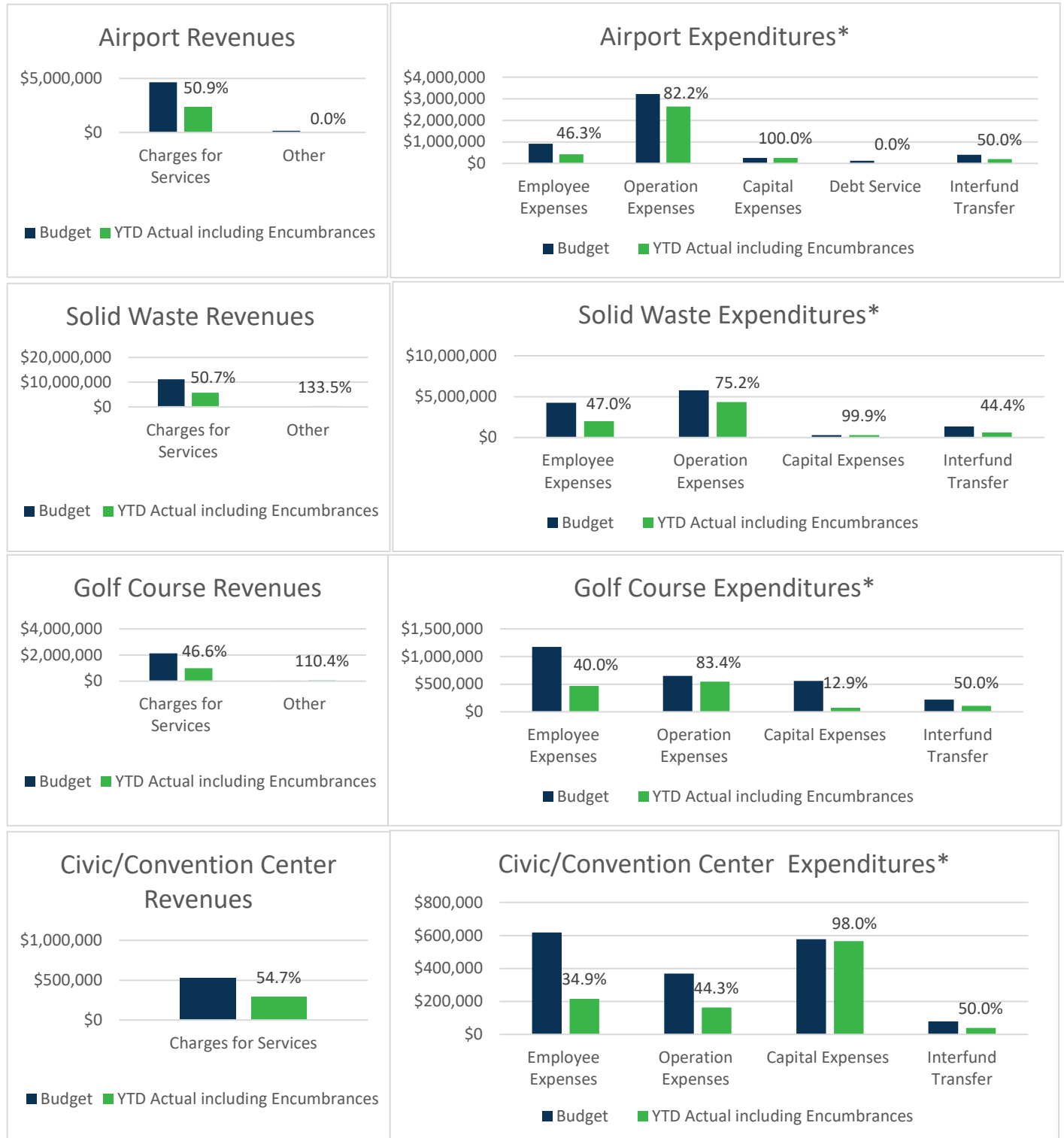

Enterprise Funds Fiscal YTD 2024 - March

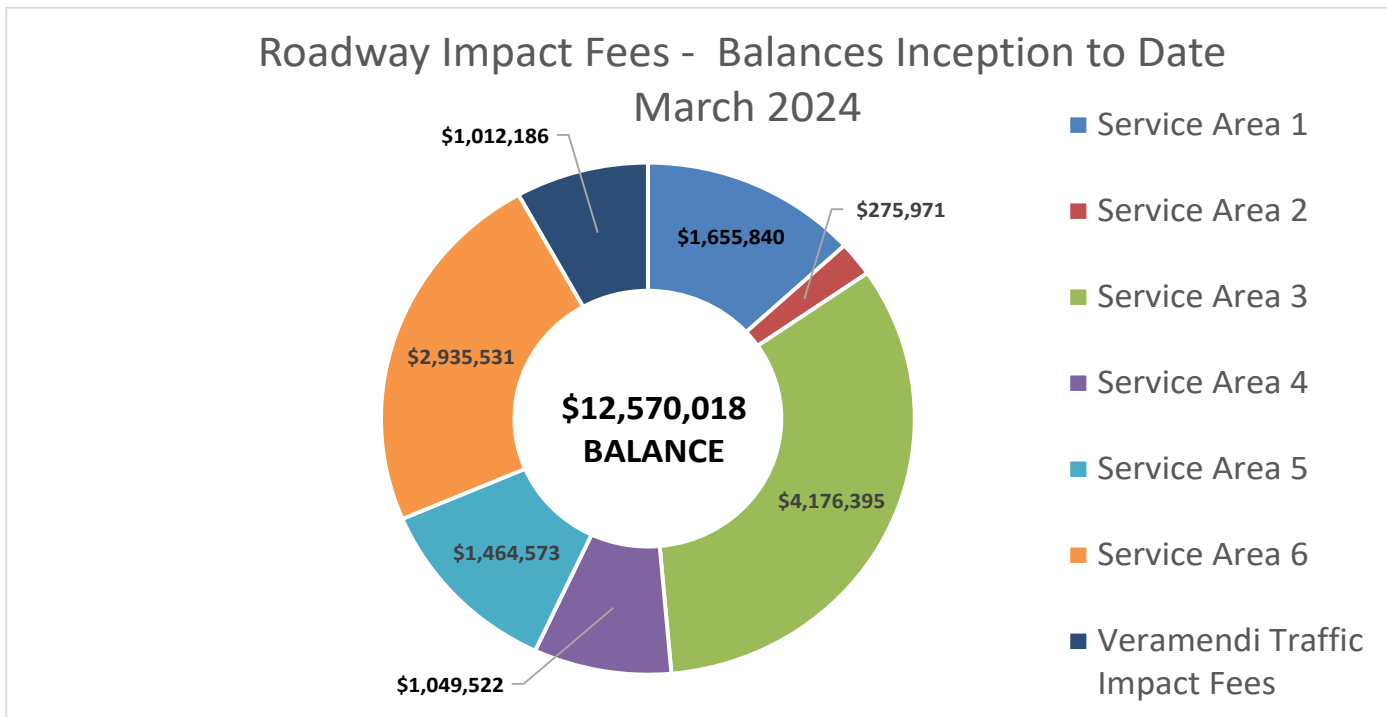

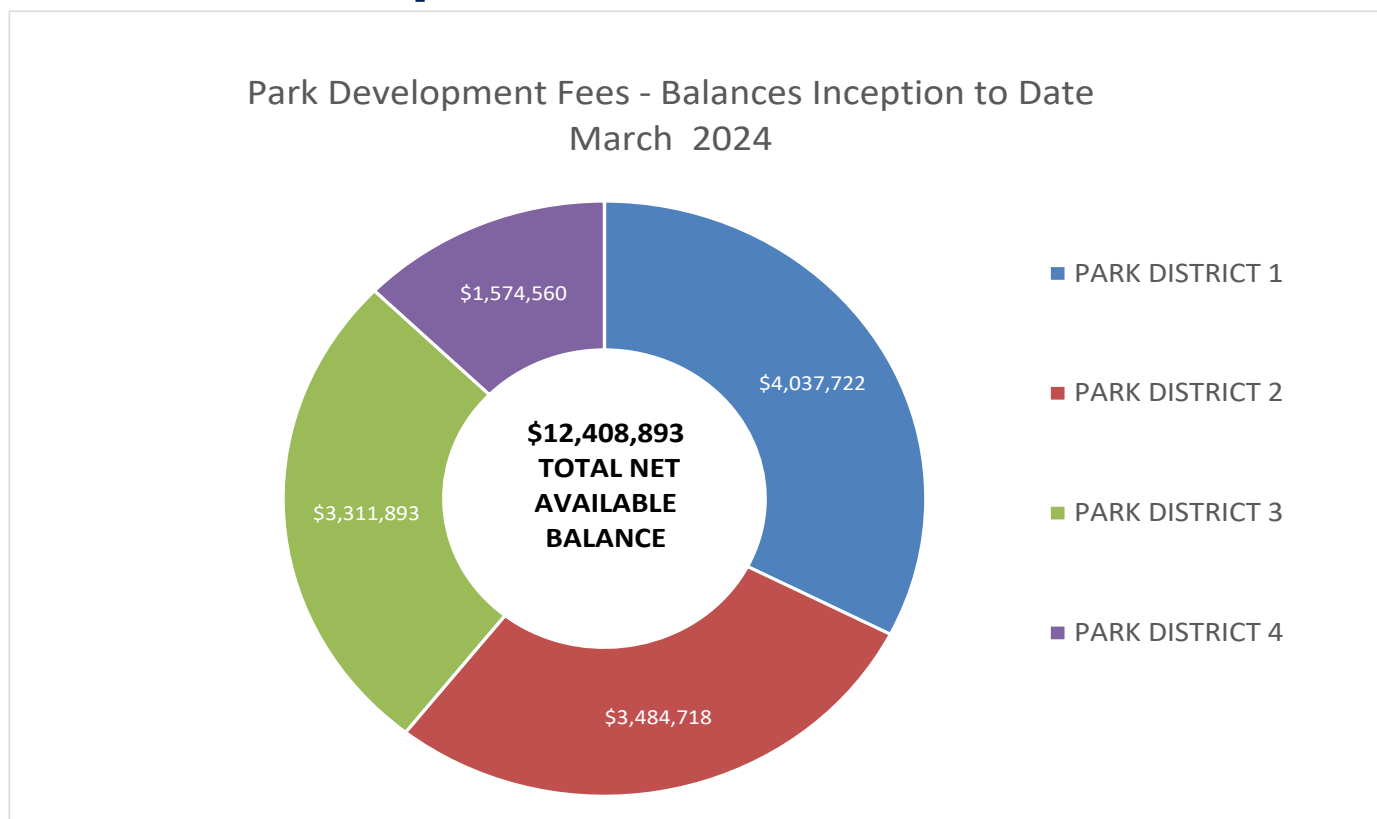

Roadway Development Impact Fees

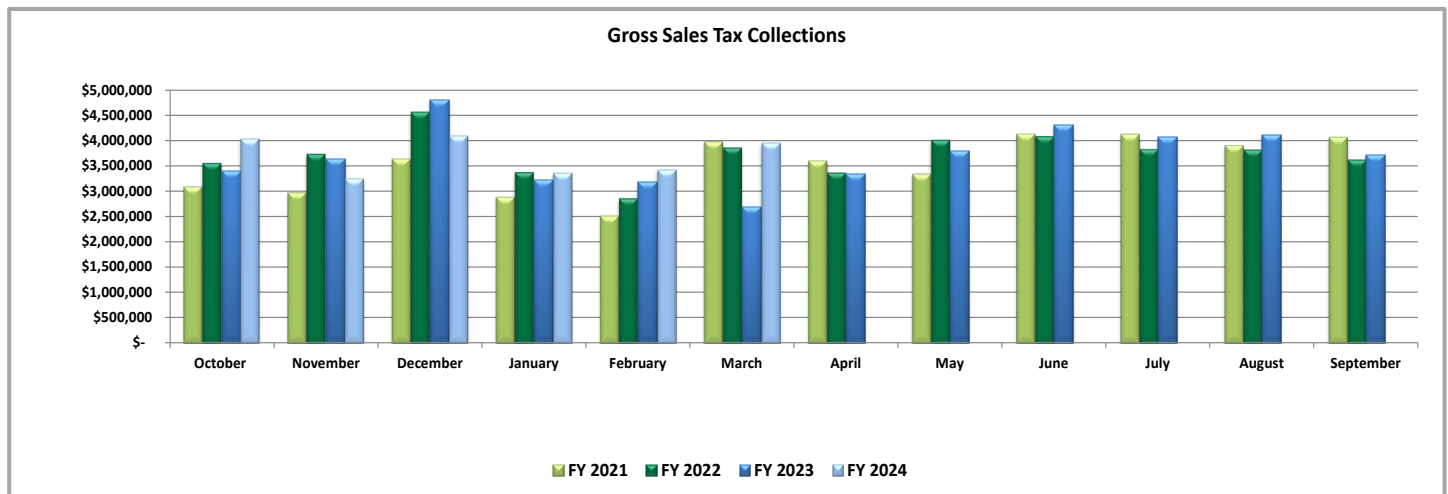


Park Development Fees



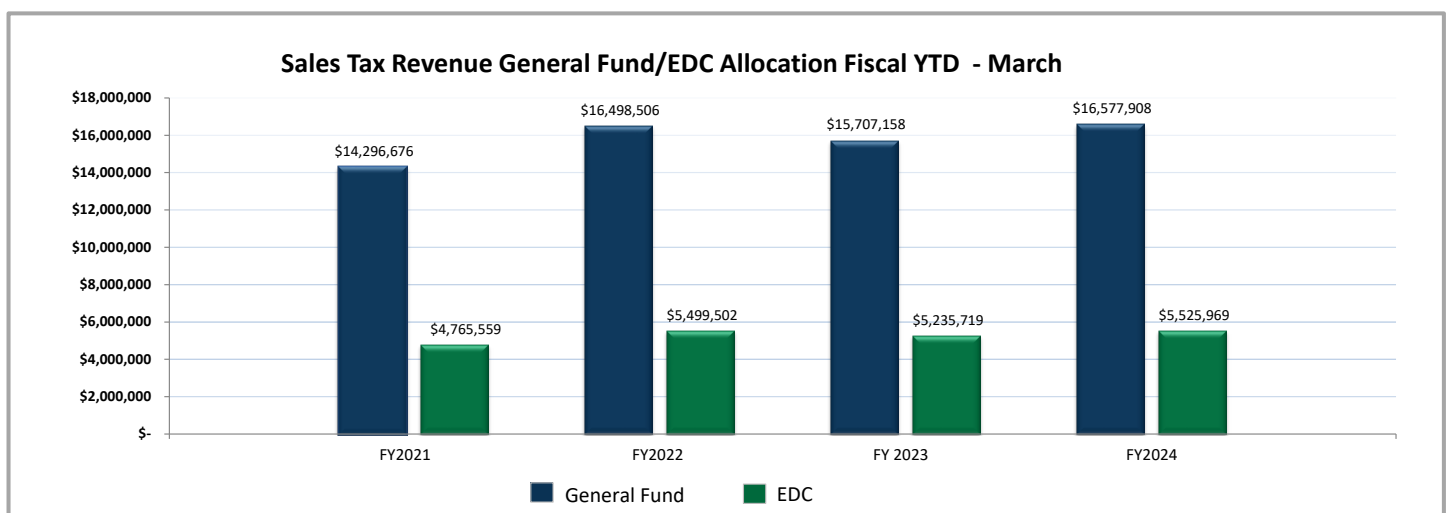

Economic Data Fiscal YTD 2024 – March



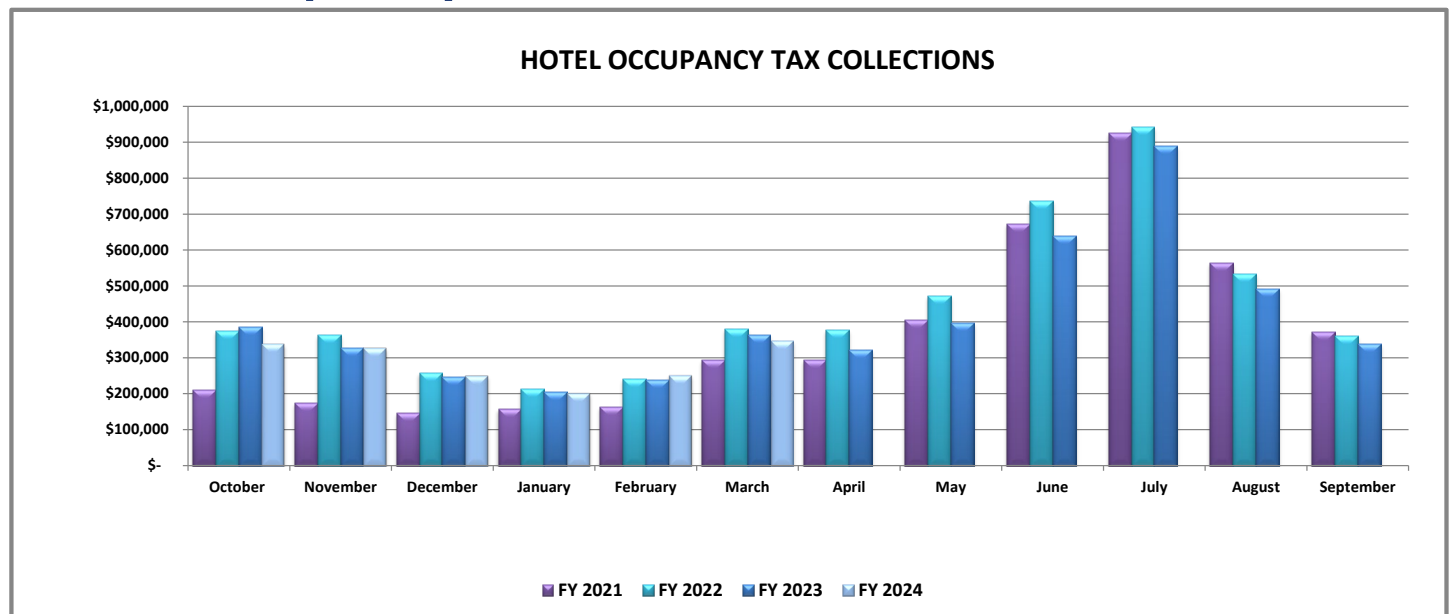
- March 2024 gross sales tax revenue was up 47.1% compared to March 2023 due to a large audit adjustment made during the previous year. Gross sales tax revenue fiscal year to date through March was up 5.5% compared to FY 2023. March's gross sales tax revenue includes any audit adjustments of made at the State Comptroller's Office.
- March 2024 current period collections, which do not include audit adjustments, increased 6.2% compared to March 2023 and up 3.6% YTD compared to FY 2023.

Hotel Occupancy Tax Collection FY 2024 - March



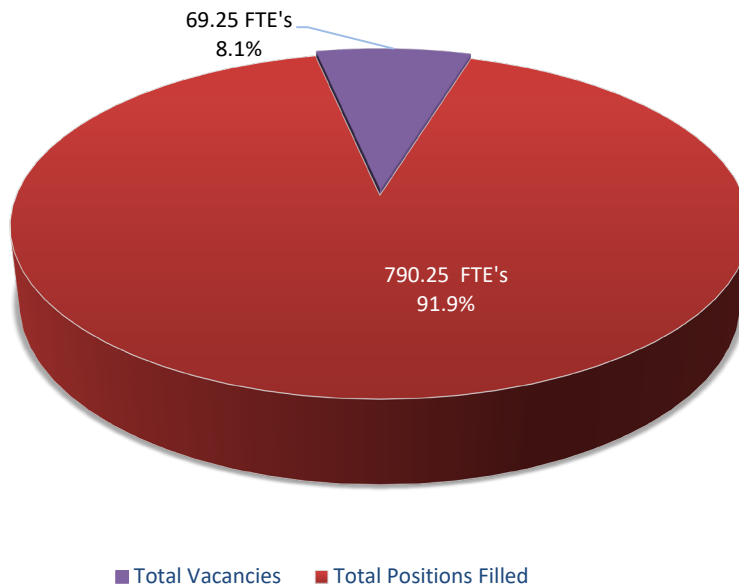
- March collections trended down this month compared to March 2023, decreasing 4.5%.
